Does the effectiveness of pharmaceuticals fade with time? Reasons and consequences

Christel Weiss (Germany)

- Evidence Practice Gap
- 3/4 studies effectiveness faded with time
- New drugs assessed on sicker patients
- Is this effect demonstrable for a wider range of drugs..?
- Is this selection bias..? (despite blinded RCT)
- Is the effect an association..?
 - due to early trials = drug company sponsored..?
