Why a journal of medical case reports?

- "The best teaching of medicine is that taught by the patient" – Osler
- Detailed information about an individual
- Neglected area for publication
- Impact on Impact Factors
- Potential to contribute to research and change clinical practice

Case reports and Evidence Based Health Care

- Case reports offer information that large scale studies cannot
- Previously unreported reactions to new medications
- Rich source of hypothesis
- Use to inform research as part of a comprehensive database with other case reports
- Teaching clinical medicine
- Resource of clinical images and teaching materials

What are we looking for?

Original case reports that expand the field of medical knowledge:

- 1. Unreported or unusual side effects or adverse interactions involving medications
- 2. Unexpected or unusual presentations of a disease
- 3. New associations or variations in disease processes
- 4. Presentations, diagnoses and/or management of new and emerging diseases
- 5. An unexpected association between diseases or symptoms
- 6. An unexpected event in the course of observing or treating a patient
- 7. Findings that shed new light on the possible pathogenesis of a disease or an adverse effect

Adverse interactions

- A fatal case of bupropion (Zyban) hepatotoxicity Extensive psoriasis induced by pegylated interferon
- Fatal miliary Coccidioidomycosis with infliximab therapy
- Anaphylactic reaction associated with Ranitidine in a person with acute pancreatitis
- Ventricular tachycardia after administration of sildenafil citrate
- Acute pancreatitis related to therapeutic dosing with colchicine
- Fluoroquinolone-associated tendinopathy

 One key aim is to provide an opportunity for medical students and recent medical graduates to start researching and writing up their own clinical observations about individual patients as part of their training in evidence-based practice





Case Summary

We describe an exploratory, data-oriented approach for identifying candidates for differential gene expression in cDNA microarray experiments in terms of α -outliers and outlier regions, using simultaneous tolerance intervals relative to the line of equivalence (Cy5 = Cy3). We demonstrate the improved performance of our approach over existing single-slide methods using public datasets and simulation studies.
